

Nomination Form for Membership of General Practice Queensland Board (F073)



The General Practice Queensland (GPQ) Limited Board is comprised of 6 elected Board Directors and up to 3 appointed Board Directors.

Nominations for the election of the 2 Directors in accordance with the constitution of GPQ should be addressed to David Phillips, Company Secretary, General Practice Queensland and received by 12:00 noon on Wednesday 8 September 2010.

Nominations will be received in accordance with the following Rules which are contained in the GPQ constitution:

Rule 11.3 (a)

“any Members who are entitled to vote in accordance with **rule 5.10** may nominate any nominee to serve as a Director;”

Rule 5.10

“The entitlement of Members to vote on a show of hands and on a poll is as follows:

- (a) each ordinary member has the right to one (1) vote on a show of hands and on a poll: and
- (b) no associate member has the right to vote.”

Rule 11.3(b)

“no person is eligible for election to the Board at any annual general meeting (or any general meeting of the Company) unless the Member intending to nominate the person has given notice in writing signed by the nominee giving consent to the nomination and signifying either candidature for the office or the intention of the Member to nominate the nominee. To be valid, the notice is required to be left at the Company’s registered office not less than 30 days, and not more than 50 days, before the meeting;”.
